Minutes of the 154th meeting of NLCPR Committee held on 17.11.2017 under the Chairmanship of Shri Naveen Verma, Secretary, Ministry of Development of North Eastern Region in Committee Room (243A), Vigyan Bhawan Annexe, New Delhi.

The list of participants is at Annexure-I.

The meeting started with the welcome note of the Chairman followed by a brief introduction by Joint Secretary (NLCPR) on the proposals received from the concerned State Governments for consideration of the NLCPR Committee. It was informed to the Committee that the proposals had the recommendation of the State SLECs for sanction of the projects retained earlier as per BE 2016-17. Thereafter, project-wise discussion stated which was participated by the officials of the concerned State Governments and the representatives of the line Ministries of the Government of India. After detailed discussions on the State-wise proposals, the Committee recommended following proposals for sanction or otherwise:-

TRIPURA

Based on the recommendation of the State Government, the NLCPR Committee recommended following projects for sanction:-

S.No	Name of the project	Recommendation of NLCPR Committee
1	Construction of District Administration Complex, Sephaijala District.	The Committee recommended the project for sanction at a cost of Rs.21.60 crore with RCC frame structure having maximum use of local treated bamboo material.
2	Construction of District Administration Complex, Khowai District.	The Committee recommended the project for sanction at a cost of Rs.20.60 crore with RCC frame structure having maximum use of local treated bamboo material.

ASSAM

Based on the recommendations of the State SLEC, following projects of State Government of Assam were recommended by the NLCPR Committee for sanction with the observation that Ministry of DoNER will fund only half of the amount proposed as GST in the appraisal report of the project if amount of State GST has not been deducted from the project cost and will not fund any contingency/consultancy charges:-

1.	Construction of Railways over Bridge at Jorhat Town in replacement of LC gate No.58 on Naali Jorhat	The Committee recommended the project for sanction at a cost of Rs.60.88 crore.
2.	Construction of Multi Disciplinary Sports Complex at Khanikar in Dibrugarh District	The Committee recommended the project for sanction at a cost of Rs.146.13 crore.
3.	Construction of NL Daulagupu Sports with 3 storied RCC Dormitory Building Haflong in Dima Hasao	The Committee recommended the project for sanction at a cost of Rs.16.11 crore.
4.	Construction of Medical College at Nalbari	The Committee recommended the project for sanction at the cost of Rs.327.29 crore with the condition that the Ministry will fund the project to the extent of its retained value of Rs.220.00 crore and balance fund would be arranged by the State Government. The Committee also recommended that the project may be phased out in such a manner so that the portion of the hospital costing up to Rs.220.00 crore may be completed in all respects by March, 2020.

Based on the recommendation of SLEC, following projects of State of Sikkim were sanctioned by the NLCPR Committee under Swachhta Action Plan:-

2.	Solid Waste Treatment Project for Mangon	The NLCPR Committee recommended the project sanction at a cost of Rs.10.00 crore subject to the condition that the component of 'operation and maintenance', if any should be excluded from the project cost

MIZORAM

Based on the recommendation of SLEC, the NLCPR Committee deliberated the proposal submitted by the State Government and recommended following projects for sanction:-

Aizawl College new campus building at Mualpui, Aizawl, Mizoram	The Committee recommended the project for sanction at the cost of Rs.12.00 crore with the observation that old buildings shall be used for health/other useful purpose and the unsafe structures shall be demolished.
4.	NIT Water Supply Scheme	The Committee recommended the project for sanction at the cost of Rs.6.15 crore.
5.	Construction of 33 kv D/C line tower from 3 MW Kautlabung SHP to Thenhlum 33 kv Sub-Station (17 kms)	The Committee recommended the project for sanction at the cost of Rs.7.82 crore with the observation that construction of sub-station would be synchronized with the progress of this project making the system thereby functional as a whole at the same time.

However, the Committee suggested the State Government to fast track the finalization of the revised DPR and submit the recommendation of State SLEC with techno-economic vetting on or before 23 rd November, 2017 so that a final view can be taken before the end of November, 2017.
2.	Construction of New High Court Complex at Kohima Phase-I	The Committee recommended following components of the project for sanction as per SLEC recommendation:- (i) Construction of residence for Hon’ble Chief Justice of High Court at a cost of Rs.2.59 crore; (ii) Construction of residences for Justices of High Court (six blocks) at a cost of Rs.11.95 crore.
