OFFICE MEMORANDUM

Subject: Revision of Guidelines for administration of the Scheme of “North East Special Infrastructure Development Scheme-Other Than Road Infrastructure (NESIDS-OTRI) circulated vide letter of even number dated 21.08.2023 – Partial modification – regarding.


In partial modification of this Ministry’s communication even no. dated 21.08.2023, the following amendments are hereby made in the guidelines for administration of the NESIDS (OTRI) of the Ministry of Development of North Eastern Region:

1.	Para 7.1.2 <i>(ix) Innovative projects for promotion of tourism in the NER States, preferably spread over multiple States and/or multiple infrastructure sectors</i>	Para 7.1.2 (ix) Projects for Industrial Development.
2.	Para 7.1.6 Minimum Project Size: <i>The minimum project size/cost will be Rs.20 crore for infrastructure projects relating to water supply, power, civil aviation etc.; and Rs.10 crore for infrastructure projects in the areas of primary & secondary sectors of education and health.</i>	Para 7.1.6 Project Size: The size of the projects eligible for funding under the Scheme shall be between Rs.5 crore to Rs.50 crore (Both figures inclusive).

2. The State Governments of NE Region will be at liberty to continue with the project proposals which have already been recommended by the EIMC for selection (in-principle approval) or sanction (DPR approval) under NESIDS (OTRI), but the AFS has not been issued. These project proposals can still be considered for sanction or issuance of AFS (as the case may be) under NESIDS (OTRI) even though the size of these projects is more than Rs. 50 crore. The projects, for which AFS has already been issued, shall not be affected.

3. This Ministry’s letter of even number dated 03.10.2023 regarding amendment in the Guidelines for administration of the scheme of “North East Special Infrastructure Development Scheme-Other than Road Infrastructure (NESIDS-OTRI) is hereby withdrawn.
