

1. OVERVIEW



- 1.1 Balanced Regional Development has been amongst the foremost objectives of economic planning in India. In this endeavour, the Union Government has always accorded due priority to the needs of the North Eastern States. However, the process received a major fillip in the late 1990s as a result of the introduction of the policy of mandatory budgetary allocation by the Central Ministries for the NE States. Further, to synergize the process of development of the region, the Central Government created the Department of Development of North Eastern Region in 2001, subsequently elevating it to the level of a full-fledged Ministry in 2004.
- 1.2 Infrastructure development is a fundamental prerequisite for realizing the vision of

- progress towards peace and prosperity and for creating an investment climate and market development in the North Eastern Region. Expansion in the supply of basic infrastructure such as efficient transportation network, power, telecommunication and broadband connectivity, is extremely important for the development of the region. Apart from delivering essential services that improve the quality of life and livelihoods, these elements of infrastructure are crucial for establishing a modern, aspirational society for the progress and prosperity.
- 1.3 While the primary role of Ministry of DoNER is advocacy with Central Ministries/ Departments, Planning Commission and the States, the Ministry is addressing the State specific Infrastructure gaps of the region



through its Scheme of Non-lapsable Central pool of Resources. Further, a number of key infrastructure projects of regional character are supported by the North Eastern Council. As a result of joint efforts of all (Centre, States, NEC and M/DoNER) infrastructure scenario in the region is undergoing a rapid transformation. This Ministry has also taken up various initiatives in collaboration with other Ministries / Departments. There are:-



- (i) Construction of a Working Women Hostel in Jasola, Delhi in association with Ministry of Women & Child Development,
- (ii) Inauguration of Centre for North Eastern Culture at Centre for Cultural Research and Training (CCRT), Dwarka, Delhi in association with Ministry of Culture.
- (iii) Sponsoring of a very innovative, noble and inclusive programme "Youth to the Edge" which entails bringing youths from rest of India to the North Eastern States for exposure and familiarisation and understanding the customs and cultures being practiced in the region in association with the Ministry of Youth Affairs.

1.4 There has been an increase in the overall percentage utilization of Central budgetary funds allocated for the NER in 2010-11 (90.84%) over previous year's 2009-10 (90.53%), Some of the heavy weight Ministries such as those of Power, Railways and Tourism by spending more than their earmarked outlays in the NER have contributed to the overall utilization. However, the outcome in terms of development has not been commensurate. For instance, the inability of the North Eastern States to implement APDRP and R-APDRP reforms has resulted in some of the problems that plague the power sector in the NE States namely: High T&D losses; under utilization of capacity / slow evacuation of power (due to lack of readiness of transmission / sub transmission lines and sub stations); inequality in power supply and consumption between districts; presence of very few rural households with even single point connections etc. of the projects of the Railways in the NER which are in the nature of game changer for more than one State, have not resulted in major increase in kilometer coverage nor in bringing about seamless connectivity in the NER. The achievement has only been in terms of limited / local point to point connectivity and gauge conversion. On the other hand, the utilization by some of the major Ministries / Departments having scope for employment generation in the region such as Agriculture and Cooperation, Textiles (including handlooms), Micro, Small & Medium Enterprises has been below expectation (taking into account

the percentage utilization for the year 2010-11 alone). Some of the service sector Ministries such as HRD (both School and Higher Education departments) which have potential for imparting skill and vocational education leading to employment have also been under spending earmarked outlays. The percentage utilization of earmarked outlay of the Ministry of Road Transport and Highways which is critical for road connectivity within NER has on an average been between 60-75% in the last 3 years of the current Plan. Many crucial ongoing road projects require greater investment thrust. In view of above, there is a need for enhancing efficiency in utilization of earmarked funds for the NER.

- 1.5 During the year, there was significant increase of budgetary support under the NLCPR and NEC Schemes. Further, the Ministry took a number of measures to streamline the selection of projects, expeditious formulation of DPR and release of funds under NLCPR. The Ministry has also tried to take into account the intraregional and intra- state disparities to rationalize project support. Development strategy for the Region has to be evolved based on prevailing resources, conditions and people's needs and priorities. Faster economic growth can only be possible if accompanied by requisite structural changes. Public investment has been going up significantly in the Region. The budgetary provision for the North Eastern States in Central Plan of various Ministries / Departments has steadily increased from Rs.3211.00 crore in 1998-1999 to about Rs. 21772.22 crore in 2010-11.
- 1.6 The Ministry of DoNER has brought out the Human Development Report of the North East States. The report is an attempt to evaluate the performance of North Eastern States in recent times on sectors having direct impact on human development such as health, education and basic amenities like drinking water and sanitation. An attempt has also been made to rank North East States in terms of a composite index employing available data and where the relevant data for generally accepted variables is unavailable, an alternative data has been used to proxy the variable. The Report shall be of help to the Central Ministries of HRD, Health and Family Welfare, Drinking Water & Sanitation and Power, in better targeting of schemes and projects in these States in order to reduce inter and intra-State disparity. The write-up as well as the extensive data base at two points of time 1993-94 & 2004-05 (including latest Census (2011), SRS & NSSO data) in terms of gender as well as rural-urban dimension will serve as a useful guide in formulation of various development policies of the Government of India.
- 1.7 Given the complexity of the task, augmenting investment to accelerate growth in the region is only a part of the story. The successful transformation of investments into development outcomes requires a variety of initiatives in every sector of the economy: primary, secondary and tertiary. The North Eastern Council has taken initiatives in agriculture sector through the introduction of double cropping and exotic cash crops. NERAMAC, a PSE of the Ministry, is providing support through



marketing, value addition and capacity building.

1.8 The North Eastern Development Finance Corporation Ltd. (NEDFi) is enlisted with the role of catalyzing project financing as well as micro-financing. The Region has rich tradition of crafts. In this regard, North Eastern Handloom & Handicrafts Development Corporation (NEHHDC), another PSE of the Ministry is providing critical support to the vast number of artisans of the region.



1.9 As a result of the efforts of the Union and State Governments in the NE Region, the landscape in the region is undergoing a considerable improvement. At the same time, there is a pressing need to improve the quality of implementation and service delivery mechanism. The constraints to implementation, which cause time and cost over- runs and adversely affect the absorptive capacity of the States, are being identified and overcome. The Ministry is vigorously attempting to improve the financial management in the States. Moreover, the requisite skill levels have to

be created. This calls for putting in place a back-up human resources development program for capacity building and training of technical man-power, other civil servants, as well as youth. NER Vision document -2020 has laid great emphasis on capacity building particularly, human development and manpower planning. Development of human resources is critical for the development of the region. While the literacy rate in the region is high, the employability of the youth in the region in skill-intensive activities and within the manufacturing and service sectors is not very high. The region does not have an adequate entrepreneurial class to take up the challenge of generating activities. economic The structural transformation of the economy can only take place by creating and enhancing the multidimensional capacities that are linked to the human resource requirements for expanding the primary, manufacturing and service sectors. While the Ministry and the NEC have taken a number of measures towards capacity building and up-gradation of skills, their efforts are also to attract the attention of relevant ministries and industry-organisations to the same.

- 1.10 Ministry of DoNER has also taken up the review of implementation of key infrastructure projects. Regular meetings are held with the States and line Ministries to expedite implementation. Besides, the Ministry takes a look at sectoral development on the basis of efforts of Central Ministries on one hand and State Governments efforts on the other.
- 1.11 The North Eastern Region is rich in natural

and human resources, both of which have not been effectively tapped. It is also a treasure trove of flora and fauna biodiversity. However, the last decade has seen a sustained effort on the part of Government of India to significantly and systematically increase the investment for the economic development of the Region. It has also invested substantially in the social sector through various schemes and programmes. A number of Central Institutions have been set up in the fields of health and HRD and all the States in the Region now have a Central University. A number of Centres of Excellence have also been set up. Initiatives of the Government are now being complemented by the private sector. This has come about because of the perception in Government of India and in the NE States regarding the path of Development of the Region.

1.12 The Tourism sector holds the highest promise for generating large employment and income- augmentation opportunities spreading and reaching down to all segments of society in all States of the North-Eastern Region (NER). Capital costs are modest compared to large industrial investments and gestation periods are short. Moreover, as is being recognized by hospitality industry all over India, the people of North-East are exceptionally well-endowed, in terms of personal and social characteristics and a long tradition of hospitality in their homes and communities, for employment in the hospitality industry. Therefore, the tourism sector should be thrust area for intervention and the region should emerge as the most favoured tourist destination. The NEIIPP is providing concessions to tourism

related projects as well. A number of new projects have come up in recent years with the support from NEDFi and other financial institutions. The erroneous perception of NER as being ridden with insurgency, militancy and terrorism is being sought to be countered through publicity campaigns in print and electronic media.

- The process of development cannot be 1.13 sustained solely through Government intervention. The private sector participation is most essential. It will not only provide additional resources but more importantly will create the necessary environment for providing job opportunities, better utilization of resources, enhanced credit flow in the region and consequent development. Ministry of DoNER is providing the necessary platform for the private sector to interact thereby paving the way for future investments. The Ministry has been encouraging this process by organizing North East Business Summits to showcase the potential of the North Eastern Region. It has also initiated the process of attracting private investment which includes foreign investments. This has been done both through the business summits and also by one-to-one interaction with specific countries.
- 1.14 As a part of strategy to showcase the potentials of NER six centres of excellence of the region i.e. Dr. B. Borooah Cancer Institute, Guwahati, North Eastern Hill University, Shillong, Rajiv Gandhi University, Arunachal Pradesh, Regional Institute of Medical Sciences, Shillong, NEIGRIHMS, Shillong and Namgyal Institute of Tibetology, Gangtok, Sikkim

were publicised in the National and Regional dailies through DAVP. A month long media campaign was launched in November, 2011 by telecast of Video Clips one each on Cultural Uniqueness of NER and NER as a tourist destination on various TV channels through DAVP, apart from undertaking many other activities.

1.15 Concerted efforts of the Central and the State Governments are helping in providing a thrust to the process of socio-economic development of the region. With properly

defined targets, clear outcomes, strategies and coordinated planning for the region as a whole, the North Eastern Region can be revitalized to become increasingly self-sufficient and a net positive contributor to the national exchequer and the country's economy. This Ministry has prepared a strategic plan for the next five years and expects to play an even more important and pro-active role to ensure both speedy implementation and a planned future development of the region.



2. AUGUMENTING INFRASTRUCTURE

2.1 Non-Lapsable Central Pool of Resources (NLCPR) Scheme:

Union Cabinet approved the constitution of a Central Pool of Resources on 15.12.1997. This pool, called as Non Lapsable Central Pool of Resources (NLCPR), was created in 1998 for accrual of the unspent balances out of the 10% earmarked for North Eastern Region in the budget of various Ministries/Departments. Ministry of Development of North Eastern Region (DoNER) are provided budgetary allocation for the NLCPR Scheme for sanction of infrastructure development projects to the North Eastern States out of the NLCPR Pool.

- 2.2 The broad objective of the NLCPR Scheme is to ensure speedy development of infrastructure in the North Eastern Region by increasing the flow of budgetary financing for new infrastructure projects/schemes. Both economic and social infrastructure sectors, such as, Power, Roads & Bridges, Education, Health, Water Supply, and Sports, etc are considered for providing support under the Central Pool.
- 2.3 Funding under NLCPR is on 90:10 (Grant: State Share) basis. From 2005-06, only 'Grant' portion is being released to the State


Governments. Funding under the Scheme can be made for State sector as well as Central sector projects/schemes. However, the funds are not meant to supplement the normal Plan programmes, either of the State Governments or Union Ministries/Departments/Agencies.

- 2.4 The Ministry issued District Infrastructure Index (DII) of NE States on 24.09.2009 which gives the status of infrastructure at district level in NE Region. It helps in targeting the projects in backward areas to reduce intra-regional disparity.
- 2.5 The guidelines of NLCPR Scheme are being amended from time to time to make it more effective. It has provision for earmarking 25% funds during retention of projects in backward/ Autonomous District Council (ADC) areas of the States for all round development of the region.
- 2.6 Up to 31.12.2011, Thirteen Hundred Twenty-eight (1328) projects have been taken up for implementation with funding from the NLCPR Scheme and Fifty-two (52) projects have been sanctioned under Special BTC Package. The total approved cost of these projects is Rs. 11280.99 crore. State wise and sector wise break up of number of projects and their approved cost



are given in the following table and also depicted graphically in the Pie chart.

2.7. Since April 1998 (the time of NLCPR becoming operational), Rs.7837.55 crore have been released under NLCPR Scheme against these projects up to 31.12.2011. From 2007-08 there is a separate budget

for Special BTC Package under which Rs.235.27 crore been released so far. A state-wise breakup of approved cost of projects and year-wise funds released is given below:

Accruals to the NLCPR Pool:

2.8. The budgetary provision for the North Eastern States in Central Plan of various Ministries / Department has steadily increased from Rs.3211.00 crore in 1998-1999 to about Rs. 23321.78 crore in 2011-12. The expenditure by Central Ministries / Department in NER during 2010-11 is worked out at Rs.19779.06 crore (Provisional), which is about 90.85% of the total allocation of Rs. 21772.22 crore. The accrual in the NLCPR during 2010-11 is worked out at Rs. 19779.06 crore (Provisional).

Implementation and Monitoring of Projects under NLCPR Scheme:

- 2.9. Projects sanctioned under this scheme are implemented by the State Governments. The timely completion of projects along with good quality of works is necessary for desired benefits to percolate to the intended beneficiaries. Therefore; emphasis has been laid on 'Effective Monitoring', which is the key to the successful utilization of resources. Ministry of DoNER has been focusing on close monitoring and evaluation of projects being implemented in the NE Region under the NLCPR Scheme. In order to ensure this, the Ministry has evolved a comprehensive system of Monitoring and Evaluation of the implementation of NLCPR projects.
- 2.10. All projects are continuously monitored through periodical progress reports received from the State Governments, depicting both the financial and physical progress of the projects and also through review

- meetings with State Government officers and inspections by officers of the Ministry. The procedure adopted for release of funds to the States for implementation of various projects under the Scheme stipulates conditions which ensure that the State Governments furnish Utilisation Certificates and other documents to the effect that the funds have been utilized for the purpose for which they were sanctioned.
- 2.11. The Planning and Development Department of each State, which is the nodal Department for NLCPR projects, has been entrusted with field inspections of the projects through senior officers of the State and submission of inspection notes. For each new project, the state/implementing agency is to identify a Nodal Officer, who is responsible for timely implementation of that project submission of progress reports. Besides, the State Chief Secretary has been entrusted with the responsibility of holding quarterly meetings for review of each of the projects and sending the proceedings to the Ministry.
- 2.12. The visits of senior officers of the Ministry of DoNER is an effective tool for monitoring as well as identifying problem areas and verifying physical as well as financial progress of the projects for prompt implementation of the projects.
- 2.13. To further strengthen the supervision, the monitoring through independent agencies have been introduced in line with JNNURM Scheme from this year. The State Governments have been asked to make presentation before NLCPR Committee



explaining the Status of operationalisation of the projects completed, Action plan for completion of the ongoing projects and the utility of the projects proposed in the annual priority list submitted by them while retaining new projects for the respective states.

- 2.14. To encourage the States for timely completion of projects an incentive scheme has been introduced. Wherein, every year for a best performing State in terms of completion rate of projects, an incentive in terms of retention of additional projects worth to Rs.20.00 crore as per their choice over and above their normal allocation is being given. This year it was given to the State of Tripura for their best completion rate of the projects.
- 2.15. Due to the steps taken by the Ministry, in the financial year 2011-12, the Ministry has been able to sanction 97 projects under NLCPR Scheme till 31.12.2011.

Project support during 2011-2012:

- 2.16. During 2011-12, budgetary provision for NLCPR Scheme is Rs.798.99 crore There is seperate budgetary provision of Rs.50.00 crore for Special BTC Package. As on 31.12.2011, Rs.620.47 crore have been released under NLCPR and Rs.15.09 crore have been released under Special BTC Package.
- 2.17. On the recommendations of the NLCPR Committee, 90 projects with a total estimated cost of Rs.1524.68 crore have been retained for techno economic examination during 2011-12. Also, 97 projects have been sanctioned at a total cost of Rs.963.59 crore during the year up to 31.12.2011. The projects sanctioned during 2011-12 do not necessarily relate to the projects retained during the year. However, the gap between retention and sanction of a project has been considerably reduced. Sector-wise distribution of projects retained / sanctioned and funds released during 2011-12 is indicated below:-

2.18. As may be seen from the above, in order to improve connectivity in the North Eastern Region highest number of projects have been retained and sanctioned in the Roads & Bridges Sector.

Special BTC Package:

- 2.19. As per the Memorandum of Settlement (MoS) signed between Govt. of India and Bodo Liberation Tigers (BLT) in the year 2003, the Government of India had agreed to provide financial assistance of Rs.100 crore per annum for 5 years (Rs.500 Crores) for projects to develop the socio-economic infrastructure in Bodo Territorial Council (BTC) areas over and above the normal plan assistance to the State of Assam. As against Rs.500 crore special Package, 42 projects have been sanctioned at a total cost of Rs.476.26 crore 2004-05 till December, 2011.
- 2.20. The Hon'ble Prime Minister during his visit to Assam in August 2008 has announced additional assistance of Rs.250 crore for the integrated development of BTC Areas. Under the above scheme a total of 19 projects at an estimated cost of Rs.243.20 crore have been retained till December, 2011. An amount of Rs.505.25 crore has been released under Special BTC Package to the State Government till December, 2011 for implementation of these projects.
- 2.21. State-wise and project-wise details of funds released from NLCPR during 2011-12 (till 31.12.2011), are given at ANNEX I.
- 2.22. State-wise details of projects sanctioned

under NLCPR during 2011-12 is given at ANNEX - II.

Non-Lapsable Central Pool of Resources – Central (NLCPR-Central)

2.23. The Union Cabinet, on 11th August 2011, approved for introduction of a new Central Sector Plan Scheme titled "Non-Lapsable Central Pool of Resources - Central (NLCPR-Central)", to become operational from 2012-13. The scheme, NLCPR-Central has been formulated with the objective of enhancing effective and optimal utilisation of funds in the NLCPR Pool towards development of the North Eastern States. The scheme is not meant to supplement the existing schemes, but to fill critical gaps in the existing developmental programmes or schemes. As a Central sector plan scheme, projects of Union Ministries/Departments pertaining to subjects listed in the Union and Concurrent Lists can be proposed for funding under the scheme. Expenditure incurred under the NLCPR-Central scheme will be debited to the NLCPR Pool. The guidelines for the scheme has been circulated to concerned Union Ministries/ Departments, inviting them to propose appropriate projects. The Governments of North Eastern States and North Eastern Council have also been kept informed about the procedure by which they may pose projects under the scheme.

2.24. Action taken in PM's Package:

Ministry of DoNER has been reviewing the progress of projects taken up by the various Ministries / Departments in pursuance

of PM's Announcements for States of Arunachal Pradesh, Assam, Manipur and Tripura. Ministries / Departments like Ministry of New & Renewable Energy, Civil Aviation, Road Transport and Highways, Rural Development, Home Affairs, Planning Commission, Urban Development, Power, Railways, Ministry of Health & Family Welfare, Commerce and Water Resources and others are taking necessary steps for fulfilment of the projects under PM's Announcements. They are furnishing their status report to this Ministry from time to time. Based on the inputs provided by the Ministries / Departments, Ministry of DoNER keeps on reviewing these projects. Ministry of DoNER also keeps PM Office and Cabinet Secretariat informed about it.

2.25. Monitoring of Important National Projects:

For the development of modern transport infrastructure in the NER, Ministry of DoNER has been reviewing the progress of various important infrastructure projects. Minister, DoNER recently reviewed following infrastructure projects:-

- i) Bogibeel Rail cum –Road Project over Brahmaputra
- ii) Lumding Silchar Jiribam gauge conversion
- iii) Erosion protection works at Rohmaria, Dibrugarh
- iv) Dhola Sadiya Bridge over Brahmaputra
- v) East West Corridor

Minister, DoNER also took up the matter

with Ministry of Railways and got finalized the tender for superstructure on Bogibeel Rail-cum-Road Project. Every effort is being made to facilitate completion of the projects on time. Secretary, DoNER also reviews progress of various important infrastructure projects including power, rail and road connectivity, civil aviation, etc. The problems faced by the subject Ministries / Departments are being discussed in such review meetings and adequate advisory is given to the concerned to complete the task on scheduled time.

Projects of NEC

2.26. HUMAN RESOURCE DEVELOP-MENT & EMPLOYMENT SECTOR EDUCATION:

The Ministry of Tribal Affairs, jointly with the Ministry of DONER/NEC, have initiated the works on construction of a 500 seats capacity girls' hostel in Delhi University for girl students from the NER and other tribal girl students studying in Delhi University. Total cost of the project amounting to Rs.23.33 crores is being shared between the NEC and the Ministry of Tribal Affairs on 60:40 basis, i.e., the NEC shares an amount of Rs13.998 Crores(60%) towards the project. Out of this amount, the NEC has so far released an amount of Rs.11.50. crores.

2.27. A 500-seater Working Women's Hostel in Jasola Delhi was constructed in association with the Ministry of Women and Child Development. Accommodation will be provided for the working women hailing



from North Eastern States. Total cost of the project is Rs.17.44 crores, wherein the NEC's share is 25%. Land cost for the hostel is being shared in 50:50 ratio. NEC has released Rs.4.36 crores for construction and Rs.0.42 Lakhs for Furniture, Electricity, Water Supply etc.

2.28. Pilot Project of sponsoring students in school has been taken up and accordingly 23 students each for all 7 North Eastern States and 2 for Sikkim are being sponsored at Assam Rifles Public School, Laitkor, Shillong for Financial Year 2011-12 in class VI. Selection/Examination conducted by Assam Rifles in all the States after

proper advertisement. Besides that, brilliant students and girl children and students from economically backward classes also need to be supported in schools and colleges. About 5,500 students have so far been benefited under this scheme during the last Financial year and equal number, if not more, are to benefit this Financial year also.

2.29. Projects supported under Infrastructure

- 2.30. The North East Regional Education Council was constituted on 18th July, 2006. The Council's scope of work will include amongst others:—
- (i) Development of HR of the NE Region including upgradation of skills;
- (ii) Improvement in the quality and standard of education in general and of Science and Mathematics in particular, in schools;
- (iii) Orientation of the educational system so that formal education generates respect for the traditional, social and cultural values of the society;
- (iv) Integration of the entire educational process from primary to University level;
- (v) Formulation of the education components of the Vision NER 2020:
- (vi) Providing institutional base to act as a catalyst and facilitate pooling of resources of all the governmental and non governmental agencies engaged in the field of education to this end, Director, NCERT was also entrusted with preparation of Training Packages for primary teachers and upper primary teachers in mathematics, science, social science and languages. Teacher's training on capacity building undertaken.

2.31. Misc. Training/Capacity Building:

Practical Employment Training programmes are being sponsored by NEC in the fields of IT and B.P.O. trainings, Tourism, Hospitality, Event Management, Air Craft Maintenance Engineering License Course, Rural Development, Hair and Beauty Care, CAD/CAM, Ayurveda Therapist, CNC Technology, Plastic Processing, Banana Fibre Extraction,

Hearing disability training, Site Supervisor and Accountant, Jems and Jewelry making etc. So far, NEC has sponsored not less than 4000 NE Youths under this scheme. The training programmes were selected keeping in mind the employability and broad spectrum of unemployed youth of the region. It therefore caters both to school drop outs as well as educated unemployed. Programes on different trades such as MAT/CAT, Civil Services entrance exams, Bank PO, Retail Management, Automobile Repairing etc are also being undertaken. These programmes are undertaken to not only equip the youths for employment but also for self employment and to fill the man power requirement need in the NER and the country. Coaching classes for NIFT entrance exams are being sponsored.

2. 32. Sports:

- i) Totap, nurture and encourage talent, national and regional events are being sponsored including tournaments like Boxing, Chess, Karate, Badminton, Cricket for physically challenged.
- ii) Courses for coaches at SAI, Wrestling, Taekwondo, Muay Thai, Tugof War, Archery, Football, Training on mountaineering, caving, river raffling all, etc are also being sponsored. Football Academy at Kolasib, Mizoram, Tennis Academy, Imphal, Stadiums in Nagaland, Construction of Multi Purpose Hall at Phetsero are under construction. Imported Archery Equipments were also purchased for SAI Imphal. Training on mountaineering, caving, river raffling, special coach on different fields.
- iii) A very innovative, noble and inclusive



programme "Youth to the Edge" is also under sponsorship. The programme which entails bringing in youths from the rest of India to the North Eastern States for an exposure trip and familiarization programme and like wise exposing the North Eastern youths to rest of India is aim at bringing about more appreciation and understanding of customs and cultures being practiced.

2.33. Chairman Sport's Award


The NEC has introduced the Chairman's Sports Award for excellence in International and National Sports meet. Under this scheme, prominent sportspersons who have achieved excellence by winning

2.34. MEDICAL AND HEALTH

2.34.1 Dr. B. Borooah Cancer Institute, Guwahati :

The only institute of its kind in the entire NER to provide treatment for Cancer and related diseases and research and imparting training of medical and paramedical personnel in the field. The hospital attached to the Institute is equipped with modern diagnostic and treatment facilities. The Institute is supported under a Tripartite Agreement between NEC, DAE and Government of Assam wherein NEC contributes 70% for recurring expenses of the hospital and institute and 30% by Government of Assam. In the areas of infrastructure development NEC and DAE contributes 50% each.

2.34.2 Regional Dental College, Guwahati:

At the initiatives of NEC, the Dental Wing of the Gauhati Medical College has been up-graded to a Regional Dental College and since then various infrastructure have been developed for academic activities. It undertakes B.D.S. courses with an annual intake of 40 students and M.D.S. courses in 5 disciplines.

2.34.3 Regional College of Nursing, Guwahati:

Undertakes Basic B.Sc. (Nursing) course with a duration of four and half years with an intake of 30 students annually and Post-Basic B.Sc. (Nursing) course with a duration of two years for in-service GNM

staff with an annual intake of 20 students per year. It has also started M.Sc. (Nursing) courses in five specialty disciplines.

2.34.4 Sri Sankardeva Nethralaya, Guwahati

is a super speciality hospital in Eye care and undertakes Post Graduate Doctoral training course in Ophthalmology. It also discharges various assigned activities under the National Programme for Control of Blindness (NPCB) of the Government of Indiaandtakespartinallnationalandregional Blindness Control Programme. During the year 2010-11, the project for Infrastructure Development for Establishment Ophthalmology Community Sri Sankardeva Nethralaya, Guwahati was





sanctioned at a total cost of Rs 473.75 lakhs. NEC is also extending financial assistance for equipment up-gradation of Vitrectomy and Occular Coherence Tomography.

2.34.5 Government Ayurvedic College,
Guwahati is the only ISM institute in
the entire NER which catering not only
health care through Ayurvedic treatment
but also undertakes B.A.M.S. course, M.D.
(Ayurvedic) and Diploma in Pharmacy
(Ayurvedic) and seats are proportionately
distributed among the NE States. With
NEC's support various infrastructure
facilities have been created.

2.34.6 Establishment of Accident and Trauma Centers in the NER.

Since the Xth Five Year Plan, NEC has been providing financial assistance to establish Accident and Trauma Centers (ATC) in locations along the National Highways to ensure prompt and emergency care to reduce the morbidity and mortality of emergency patients due to road accidents and other natural calamities. With NEC's financial support, ATCs at Nongpoh, Jowai and Tura (Meghalaya), Kolasib and Serchhip (Mizoram) and Mokokchung and Dimapur (Nagaland) have already been completed and providing services. Presently, ATCs at Along (Arunachal Pradesh), Namchi (Sikkim) and Agartala and Kulai (Tripura) are under implementation.

2.36. EVALUATION & MONITORING:

- i) NEC funded projects are being monitored on a regular basis regarding the physical and financial progress. NEC is also taking up the matter with the Planning Department of all the eight State Governments for submission of regular progress reports of NEC funded projects. Apart from this, from time to time, inspections are being carried out by the officials of NEC.
- ii) An initiative to evaluate the various NEC funded projects has been undertaken. MoUs were signed with various Central/State





Government organizations/ institutes like IIE, Guwahati, AAU, Jorhat, NEIGRIHMS, Shillong, Assam Engineering College, Guwahati, Regional Engineering College, Jorhat, National Institute of Technology (NIT), Tripura, WAPCOS Ltd., Kolkata, ICAR etc for undertaking evaluation studies of NEC funded projects. The evaluation studies of some of the projects entrusted in the previous years have already been completed whereas evaluation of the remaining projects is going on.

- iii) NEC is also been providing financial assistance in the form of gap funding to various institutions like Universities, Colleges, etc for organizing seminars/symposia/workshops etc. Funding is being extended for conducting such seminars/symposia/ workshops where the theme/topics relate to issues of socio-economic development of the North Eastern Region.
- iv) NEC is also implementing a scheme to provide financial assistance to State Governments for preparing Detailed Project Reports (DPRs) of developmental projects. This has enabled the State Governments to entrust the preparation of DPRs to a reputed agencies/ firms which are having adequate expertise and manpower in such areas.

2.37. **POWER:**

The North Eastern Council has played a major role in the economic upliftment of the region through infrastructure development in the power sector. In 1981, the installed Capacity of the North Eastern Region was 410 MW only. The increase in generation capacity of North East has been made possible by the active involvement of the North Eastern Council. The NEC since its

inception has contributed a total of 694.50 MW of capacity addition comprising 630 MW Hydro and 64.5 MW Thermal Projects, which is about 30 % of present installed capacity. The total investment in the projects has been of the order of Rs.3428.09 crore, out of which the investment of NEC is 52%, (Rs.1773.09 crore).

However, amatching Transmission system to evacuate power from the generating station to efficiently distribute it within the region, system strengthening like improvement/ construction of power transmission and distribution lines and upgradation of substations are also needed as per the mandate of Pasighat proclamation on Power Sector. Accordingly, several Transmission lines including the distributions and Sub-Stations of NE Region are being supported by NEC. Out of the total length of transmission lines of 11075.295 CKt Kms in NE Region, NEC has contributed to 1772.44 Ckt Km which is around 16% so far. Out of 73 numbers of system improvement projects sanctioned by NEC spread over all the eight States of the region, 34 numbers have been completed and remaining 39 numbers are in various stages of progress. During 2011-12 up to December 7 numbers of such projects have been completed by the different states of NE Region. The approved cost of all the 73 projects is Rs. 455.58 Crore, and out of which, Rs. 327.05 Crore has been released against the above projects as on 18.12.2011. Apart from the above, the sector has been supporting viability gap funding to Renewable Resources of Energy schemes which include micro/ mini hydel projects, solar hybrid and wind energy projects, etc. So far, five such projects

have been taken up by NEC, out of which three have successfully been completed by the executing agency. The approved cost of the five ongoing projects is Rs. 22.84 Crore and an amount of Rs.10.14 crore has been released so far. During 2011-12, two projects one each in Manipur and Sikkim have been completed by the implementing agencies.

2.38. INDUSTRIES SECTOR, NEC:

- NEC had sanctioned a study on Border Trades in the NER to be undertaken by the Research and Information System for Developing Countries (RIS), New Delhi as an effort to understand the trading scenario and possibilities of improving the trades with neighbouring countries. On 16th May, 2011, RIS gave a presentation of their findings at the NEC Secretariat, Shillong. The suggestions came out during the discussion following the presentation were noted for finalization of the report. In the first week of November, 2011, RIS had submitted the final draft for approval of the NEC. NEC had given its approval vide letter dated 18th November, 2011. The final report is being printed now. The report would be useful for planners and policy makers.
- Steps are being taken to complete all the ongoing projects at the earliest. Notable amongst them are the following,
- Project for Livelihood Development through Pilot Bamboo Enterprise for Rehabilitation of Surrendered Militants of Tripura.

- ii) UNIDO-CBTC Phase II project which is in the last year of its implementation.
- Capacity Building Programmes have been given due importance during the year and organisations such as NERAMAC, NIRD, NEHHDC, NSCI and CBTC have been supported for implementation of projects in this regard.

2.39. TOURISM SECTOR, NEC:

- The much talked about and the most important activity in which NEC will get involved in the coming days is the Promotion of Tourism in the region. NEC has got prepared the Comprehensive Tourism Master Plan for the NER through the Tata Consultancy Services, Mumbai. Implementation of the recommendations contained in this Master Plan is likely to be kicked off with the onset of the 12th Five Year Plan.
- NEC has supported a number of Capacity Building Programme in the Tourism and Hospitality Sector for developing the manpower in this segment. An important programme is the Certificate Course for six months duration conducted by the Rajiv Gandhi Indian Institute of Management, Shillong. There are two such courses to be organized under NEC sponsorship. The first course would be completed in mid-January, 2012 and the second course would start from the end part of January, 2012 or first week of February, 2012.
- NEC has also taken up programmes through the State Government agencies

of the NEC for publicity campaign and publication of tourism materials for focusing the NER as a Tourism Destination.

- I.T. Education Infrastructure has been extended to 50(Fifty) schools in Meghalaya and also financial Assistance for setting up of community Information and Education centre in NERCORMP projects District. Support has also been extended for 100 schools in the State of Mizoram.
- 6. Public Awareness of Science & Technology (Science Centers, Science Awareness Campaign, Development of Technology Lab/Planetarium, Aquaries, etc)
 Under this programme I.T base Science and Technology Awareness Programme has been completed for 100 (one Hundred) schools of Meghalaya.

Besides, following ongoing projects are progressing:

- 7. Automation of Manual Inner Line Permit System in Arunachal Pradesh.
- **8.** Computerization of Food and Civil Supplies and Consumers Affairs Department.
- 9. Developmental planning and Application of Space Technology for Agro-horticulture and Medicinals in Arunachal Pradesh.

2.41. TRANSPORT AND COMMUNICA-TION SECTOR:

Presently 24 road projects of 10th Plan & 15 road projects of 11th Plan are in different stages of progress. During the current financial year, 212 km of formation cutting and 123 km of pavement have been completed.

2.42. NEC has so far sanctioned thirteen ISBT/

ISTT projects. Seven ISBT and three ISTT projects have been completed, while the remaining two ISBT and one ISTT projects are targeted to be completed by March, 2012. ISBT at Imphal was inaugurated by Hon'ble Prime Minister on 3rd December, 2011.

- 2.43. Up-gradation works of 10 Nos. Airport project are being implemented by AAI and most of the works have since been completed. Operation of air services by Alliance Air was extended for two years from 1st January, 2010 to 31st December, 2011 @ Rs. 47.07 cr. per year under an MoU with Alliance Air.
- 2.44. Against the budget allocation of Rs. 370.02 cr. during 2011-12, a sum of Rs. 302.96 cr. have already been released till January, 2012.

2.45. IRRIGATION AND FLOOD CONTROL SECTOR:

The Budget Estimate (B.E.) for the Current financial year i.e., 2011-12, for this sector was Rs. 31.50 Crores, this figure itself being a substantial increase over the B.E. of Rs. 23.50 Crores in 2010-11. However, the requirements of the sector are such that this year, almost the entire B.E. amount had to be spent on releases for ongoing projects only. Hence, another amount of Rs. 20.00 Crores has been re-appropriated to this Sector from other sectors. NEC is funding Survey and Investigation of 12 (twelve) Hydro Electric Projects, 2(two) minor irrigation schemes and 8 (eight) Flood &

Erosion control schemes of NE Region during 2010-11. These are being carried out by the Central Water Commission, Brahmaputra Board and Meghalaya Energy development Corporation. Further, NEC has taken up 3(three) Water Supply Schemes, 1(one) Drainage development schemes and 2(two) River training Schemes for Sikkim. The NEC has taken up a few Irrigation Projects 2(two) in Assam, 1(one) each in Mizoram and Nagaland. It has approved a Bio-diversity Conservation Scheme on the Basistha Bahini Watershed near Guwahati which is to be implemented by the Soil Conservation Department, Govt. of Assam.

2.46. SOCIAL AND INFRASTRUCTURE DEVELOPMENT FUND:

The Union Finance Minister in his budget speech for 2008-09 had announced a Social and infrastructure Development Fund (SIDF) of Rs. 500 Cr. for meeting the urgent needs of North Eastern, especially Arunachal Pradesh and the Border Areas that cannot be tackled in the usual course through normal schemes. In pursuance of this Ministry of DoNER had in Consultation with North Eastern States identified 15 projects for taking up under the Fund at a total estimated cost of Rs. 586.20 crores. The Fund has been enhanced to Rs. 586.20 crore. Eight projects have since been sanctioned at a cost of Rs. 311.63 crore and the remaining projects are at various stage of consideration. Detailed current status of the Projects is available on this Ministry's website www.mdoner.gov.in.







3. PRIMARY SECTOR



3.1 NERAMAC (North Eastern Regional Agricultural Marketing Corporation) Ltd, a Government of India Undertaking under the Ministry of Development of North Eastern Region (DoNER) has been playing a significant role by sourcing, procuring & marketing of cash crops like ginger, fresh pineapple, cashew nut etc from the farmers and the growers of North Eastern Region. It has taken up its role as dynamic and vibrant marketing organization essentially to support the famer's interest in production by application of post harvest technology thereby arrest decline in prices arising from larger output of farm produces. Corporation achieved a turnover of all time high of Rs.101.65 Crore during 2010 - 2011 as compared to Rs.89.90 crores during 2009-10. There was a resultant increase of 13% in turnover corresponding to last year.

The Company during the year 2010 – 11 earned a gross profit of Rs.4.18 crores as compared to that of Rs.3.73 crore during the previous year, resulting in an increase of 12%. NERAMAC has been procuring agro-horticultural produces like Pineapple, Ginger, Orange, Hill grass, Cashew nut etc. from farmers. These operations have helped farmers in getting better price. Corporation is providing marketing support by procuring processed products manufactured by the FPO registered units set up spread all over the region for supply through its own outlet and also to end users/other buyers. Corporation also promotes their products by participating in various exhibitions at State & National Level thereby helping & introducing range of exotic produces & products of the NE Region.



3.2 SHARE CAPITAL

The Authorized Share Capital of the company as on 31/3/2011 remains same as in the previous year and stood at Rs. 10 Cr. The paid up Capital of the company as on 31/3/2011 remains same as in the previous year and stood at Rs. 7.62 Cr.

3.3 PRODUCTION

The Fruit Juice Concentration Plant at Nalkata processed 270.38 MT of pineapple, the Cashew Processing Unit at Agartala processed 56.00 MT of raw cashew nut and produced 11.25 MT of finished product and Ginger Processing Plant at Byrnihat processed 113.33 MT of fresh Ginger to produce fresh graded ginger, oil & powder during the year 2010-2011

3.4 PROCUREMENT & MARKETING ACTIVITIES

Main thrust of the Corporation is the Procurement and Marketing Activities.

Corporation has also marketed various other items like processed products, maize, Ground Nut Cake, input supplies like fertilizer, assorted seeds, planting materials etc.

4.1 NEDFI was set up in 1995 (in Ministry of Finance) with an objective to finance creation, expansion and modernisation of industrial entrepreneurs and infrastructural projects to accelerate industrial development in the region with an authorised share capital of Rs. 500 cr. and initial paid up capital of Rs.100 cr. contributed by IDBI 25%, SBI 15%, LIC 15%, SIDBI 10%, IFCI 10%, ICICI 10%, SUTI 10% and GIC & its subsidiaries 5%. However, in 2001 when this Ministry came into being, NEDF1 was transferred from Min of Finance to this Ministry.

4.3 MICRO FINANCE: The Micro Finance Scheme, an effective instrument for financial inclusion, was launched to meet the needs of smaller entrepreneurs in the remote areas of the Region. Till the FY 2010-11, cumulative sanctions and disbursements were Rs.101.19 crore and Rs. 95.45 crore respectively to 422 NGOs/MFIs/CBOs from 8 North Eastern States, to reach out to 159983 beneficiaries, of which 83% are women. 4.5 DEVELOPMENTAL ACTIVITIES UNDERTAKEN DURING APRIL-NOVEMBER 2011

TEDF STUDY:

NEDFi conducts various techno economic feasibility studies for the North Eastern Region. Over the years NEDFi have already completed 62 studies. Study & Action Plan for promoting Fruits & Vegetables Processing industries in the state of Arunachal Pradesh is one of the important ongoing studies for the current year 2011-12.

4.6 CAPACITY BUILDING OF ARTISAN ON WATER HYACINTH CRAFT:

NEDFi has embarked on a 3 year project with the support of the North Eastern



Council (NEC), Ministry of DoNER, Govt. of India for the development of Water Hyacinth Craft in the North Eastern Region. NEDFi has helped in skill building capacity of over 700 artisans. Around 11 Nos. of programmes were conducted during the period from April to November 2011, where 280 nos. trainees attended.

4.7 MARKETING SUPPORT:

NEDFi Haat: Till November 2011, fifteen fairs were organized at the NEDFi Haat, Ambari and facilitated sale of products worth Rs. 1.64 crore. NEDFi Haat mostly provide support to the un- organised sector of the industry. Artisans from the rural areas are provided with a platform to market their traditional and indigenous products during the various fairs organized at the NEDFi Haat.

4.8 INDIA INTERNATIONAL TRADE FAIR 2011:

NEDFi participated in the India International Trade Fair 2011 organized at Pragati Maidan, New Delhi from 14th to 27th November 2011 with the support of the Govt. of Assam. Products made from Water Hyacinth were displayed during the event. Live demonstration on the production of the craft was also made during the event.

4.9 BUSINESS FACILITATION CENTRE (BFC)

To fulfil its mandate of accelerating the pace of industrial development of

the north eastern region, NEDFi has set up its first Business Facilitation Centre on November 1, 2011 at the premises of Aizawl Branch Office to assist, guide and mentor potential entrepreneurs in the MSE sector. This Centre is manned by a Mentor in Branch office for providing project consultation and advisory services to Micro and Small Enterprises for a period of one year. The BFC will be taken up as project mode with an objective to provide advisory services and guidance to potential entrepreneurs and to develop at least 50 entrepreneurs within a period of 1 year. In this BFC, NEDFi will be targeting up to the project cost of Rs. 50 lakh. NEDFi propose to work in close coordination with SIDBI/ State Govt. for this BFC.

NORTH EASTERN HANDICRAFTS AND HANDLOOMS DEVELOPMENT CORPORATION (NEHHDC)

4.10 The Corporation plays a key role in the development and promotion of the

Handicrafts and Handlooms sectors of the North Eastern Region by way of providing training to the artisans and weavers through conduct of awareness seminars and workshops; Design and Technical Development Workshops and Integrated Design and Technical Development Projects. The Corporation also provides marketing support through procurement of Handicrafts and Handlooms directly from the artisans, weavers, Self-Help Groups at clusters and selling the same through its Purbashree Emporia located in Bangalore, Kolkata, Delhi, Guwahati and Shillong and also through its Sale Promotion Office at Chennai and through various exhibitions in the country. The Corporation also enables the artisans and weavers to sell their products directly through the North East Trade Expos, North East Crafts Fairs and the exhibitions held in various parts of the Country. During 2011-12, the Corporation achieved a gross turnover of Rs. 921.00 lakh (Provisional) till 10th December, 2011. The main activities of the Corporation during the year are as under:-

Exhibitions/Craft Bazars:

• During 2011-12 (upto December, 2011), the Corporation conducted 20 exhibitions and 13 Crafts Fairs (CF) in various cities and towns of the country providing direct selling benefits to 1900 artisans and weavers from the North Eastern Region. Eighteen more exhibitions and thirteen more CFs are slotted to be held during last quarter of the financial year. In addition, two Trade Expos one each at Goa and Indore are also planned.

Seminars:

• The Corporation organised a Seminar at Shillong on 19th April, 2011 another at Itanagar on 2.9.2011 on Advocacy and Knowledge Sharing with active participation of artisans and weavers of Meghalaya and Arunachal Pradesh respectively. This was followed by another Seminar at Shillong on Exportable Artistic Textiles of the North East and on various issues with participation of artisans, weavers, designers, NGOs, SHGs, Govt. Departments etc.

The Corporation is also implementing two Capacity Building-cum-Training Programme in Handicrafts and Handlooms at Soulkuchi and Barpeta Assam.



5. BUILDING CAPACITIES & COMPETENCIES

5.1 Capacity Building and Technical Assistance Scheme:

- 5.1.1 A major development requirement for the North East Region is the strengthening of its human resources, particularly the youth, so as to make them skilled and employable. The Ministry of DoNER is implementing a programme for the people of the North Eastern Region for acquiring skills and competencies through its Capacity Building and Technical Assistance Schemes during 2011-12 also. The basic objective of this plan scheme is to provide skills and competencies for self-employment and employability and also assist in providing any other specialized inputs required for Human Resource Development in sectors that are critical for the development of the region.
- 5.1.2 The target group under this scheme is the youth from the North East Region with the special focus on youth who have passed or failed 10th Standard with special emphasis on rural and backward areas. The scheme focuses on making poor youth ready for the job market. As it puts youth in quality institutions in different parts of the country, it promotes exposure and integration of NE youths to opportunities available in the rest of the country. Middle level officers in the State Government /Organizations are also covered under the scheme.
- 5.1.3 Concerted efforts were made during the

year 2011-12 to impart training in skill development to students from North Eastern Region through institutes with high reputation in the field which are functioning under the Government of India such as:

- 1. CIPET (Central Institutes of Plastics Engineering Technology): Ministry of Chemicals & Petrochemicals

5.2 Achievements:


During the current year 2011-12, an amount of Rs.20.00 crores has been allocated under the scheme for implementing the programmes on skills training and development of competencies in diverse sectors like Hospitality, Tourism, Technical Courses, Apparel, IT-ITES, Finance & Accounts, Road Highways, Construction Trades, etc. Trained candidates through the accredited institutions/ PSUs under this scheme are expected to find placements or acquire self-employment of their own in their respective areas of competencies. The number of candidates underwent training and institutions are as under:

- 40 nos. State Civil & Financial Services Officers of NE Region provided training at NIFM, Faridabad (M/o. Finance)
- 800 highway engineers of NE-State Governments imparted trainings in highway construction at NITHE, Noida (M/o. Road Transport & Highways)
- 120 unemployed youth undergoing trainings at DOEACC, Kolkata (M/o. Information Technology)
- 400 unemployed youths given trainings in Tally 9.ERP accounting by Tally (India) Pvt. Ltd.
- 158 youths undergoing training in Tourism, Travel, Hospitality sector at Bangalore/Mysore by AIH&TM (ITDC, M/o. Tourism)
- 400 unemployed youths provided skills training in construction trade through National Academy of Construction, Hyderabad.
- 120 students provided skills training in apparel sector by NIFT, Kolkata (M/o. Textiles)
- 100 unemployed graduates to undergo training in tourism & travel at IITTM, Gwalior (M/o. Tourism).
- 500 school dropouts undergoing skill training in various construction trades at Construction Industry Development Council (CIDC), Noida.
- 30 unemployed 10th failed youths undergoing Crane Operator and Back Hoe Loader skills training through MITCON at Guwahati.
- CIPET Centres, Chennai, Bhubaneswar, Guwahati and Imphal (M/o.Chemicals & Petrochemicals) provides skills training to unemployed NE youths in various areas of plastics technology.



- About 670 unemployed youths are to be provided skills training in various machinist courses under MSME's Tool Rooms at IDTR- Jamshedpur and CTTC-Bhubaneswar.
- 300 unemployed youths to be trained in Special Machine Operation course by AEPC (M/o. Textiles).





5.3 Training in Managerial Skills and Enhancing Competencies for the Government officials of NE States:

(i) Indian Institute of Technology, Guwahati : - IIT, Guwahati has been roped in to provide trainings to junior level engineers of Irrigation Department, Govt. of Assam, in river bank erosion problem. An initial advance of Rs.7.45 lacs was released in the 1st installment for organizing this program for 30 participants.

(ii) National Institute of Financial Management (NIFM), Faridabad: NIFM, Faridabad has imparted training program to the Civil and Financial services officers of the North East States in rationale decision making process for which an amount of Rs.26.40 lacs was released on successful completion of the course.



5.4 Training for the youth in vocational and various other trades

- (i) Indian Institute of Tourism & Travel Management (IITTM), Gwalior :- IITTM, Gwalior was provided R 87.00 lacs out of which R43.50 lacs was released for imparting tourism promoter program to 100 graduates for development of their self-employment opportunities. The training program is underway.
- (ii) Skills Training in various Construction Trades: The Construction Industry Development Council (CIDC) has started skills training programs in various activity of construction trades for target number of 500 trainees. Out of Rs.1.03 crore (apprx.)



- sanctioned, the Ministry has released Rs.77.47 lacs so far to CIDC who have trained 252 youth uptil now and 101 are undergoing training/ counseling.
- (iii) Training in Hospitality, Travel/Tourism and Aviation—M/s. Ashok Institute of Hospitality and Tourism Management, ITDC, New Delhi who was selected to impart training in Hospitality, Travel/Tourism and Aviation for 180 North-East candidates has carried out the training courses at Bangalore and Mysore. So far 158 candidates have been reported to undertake the courses which are going smoothly. Against total project cost of Rs.2.04 crore, the Ministry has released
- Rs.92.03 lacs in the first instalment.
- (iv) Training in Crane Operation: MITCON Consultancy & Engineering Services Limited" New Delhi/ Pune has been sanctioned Rs.10.50 lacs and released Rs.3.15 lacs to provide skills trainings in Crane Operation (12 ton Hydra Crane) and Back Hoe Loader driving skills to 50 unemployed youth of NE region. The course has already started at Guwahati.
- (v) National Skill Development Corporation:
 Vocational skills training program has been implemented through the NSDC at Pune for rehabilitation of 126 unemployed youth from outfits group of Manipur for which an

- amount of Rs.38.40 lacs was released by this Ministry. The course has been successfully completed and 80 trained candidates have found commensurate job placements.
- (vi) Central Institute of Plastic Engineering & Technology (CIPET) (Ministry of Chemicals, Petro-Chemicals & Fertilizers:-CIPET, Chennai is conducting CAD/CAM training programmes in Plastic Engineering Technology at a total cost of is Rs.2.0 crore for 100 candidates from NE region. An amount of Rs.1.50 crore has been released and the training has started. Similarly, CIPET Bhubaneswar has been provided an amount of Rs.2.88 cr. out of which Rs.1.64 cr. has been released to impart training in plastics technology to 480 unemployed youth from NE region.
- (vii) Tool Rooms (Ministry of Micro, Small & Medium Enterprises) :- Indo-Danish Tool Room at Jamshedpur and Central Tool Room & Training Centre (CTTC), Bhubaneswar are imparting training to unemployed youth of NER in high tech CNC and CAD/CAM area, tool making and operations and advanced machinist course, at a cost of Rs.2.12 crore and Rs.3.28 crore. An amount of Rs. 1.06 cr. and Rs. 1.64 cr. has been released to the respective institutes. These programmes are very useful and provide ample employment opportunities. 310 students at IDTR, Jamshedpur and 360 students at CTTC, Bhubaneswar are being trained.







6. MAINSTREAMING & SHOWCASING



6.1. Scheme of Advertising & Publicity:

The Scheme aims to showcase the inherent economic, social and cultural strength of the region as well as to mainstream it with the rest of the country to move forward in its entirety and also to publicize various schemes of Central Government being undertaken for development of NER as well as the achievements of this Ministry. For this purpose, this ministry provides financial assistance to various central/state/autonomous organisations/public enterprises/public trusts / NGOs etc for organising / undertaking various activities/events. The activities / events include:

- Seminars, Workshops, Exhibitions,
- North East Business Summits, Trade Expos,
- Buyer-Seller Meets in diverse areas such as trade & investment, tourism,

handlooms & handicrafts, agriculture etc.

- Evaluations/impact studies/assessments,
- Media campaign.
- Any other activity considered appropriate.
- 6.2. Proposals received from eligible organisations as per the Guidelines of the scheme are considered by a Committee chaired by Joint Secretary in charge of the Scheme with members from other Ministries and IFD. After approval of the recommendations of the Committee by the competent authority, financial assistance as approved is released to the concerned organisations with the concurrence of IFD. Progress of the projects sanctioned is monitored through reports, Statement of Expenditure, Utilisation Certificate, photographs / video graphs etc.



- 6.3. To finalise the strategy/action plan for 2011-12,a meeting with the stakeholders was held on 18.4.2011. Taking into account the suggestions which emerged out of the meeting, a strategy/action plan for the year was finalised with the approval of hon'ble Minister, DoNER. The action plan included highlighting centres of excellence in North Eastern States and the rich cultural heritage of the region through media, providing financial assistance for organising trade expos, seminars, workshops etc. through non-governmental governmental / organisations to disseminate knowledge, organising North East Business Summit for business investments, activities for furtherance of investments for skill development in the region etc. As a follow up the following initiatives/programmes have been undertaken during the year.
- 6.4. Print Media: As many as six centres of excellence i.e. (1) Dr. B.Borooah Cancer Institute, Guwahati, Assam, (2) NEHU, Shillong, (3) Rajiv Gandhi University, Arunachal Pradesh, (4) RIMS, Imphal,(5) NEIGRIHMS, Shillong and (6) NIT, Gangtok were published in various national dailies and newspapers of North East through DAVP with a view to disseminate the information / potential in the sectors of health services, Education etc. available in the North Eastern Region. This initiative was undertaken for the first time under the scheme.
- 6.5. Electronic Media: Two video clips one each on cultural uniqueness of NER and NER as a tourist destination were telecast on various TV channels through DAVP during the month of November, 2011.

6.6. Seminars / Workshops / Expos etc:

- (i) Rs.40 lakhs was sanctioned to ICC for organisation of 7th North East Business Summit at New Delhi on 6-7 January, 2012 to disseminate information about the investment opportunities available in NER.
- (ii) Financial assistance of Rs.60 lakhs extended to NEHHDC for organisation of 20 exhibitions and 13 craft bazaars at various places in the country to promote and show case the potential of handicrafts and handlooms of NER. A sum of Rs.39 lakhs was also sanctioned to NEHHDC for organising of two Trade Expos one each at Goa and Indore during the year.
- (iii) A sum of Rs.25 lakhs was sanctioned to CII for organisation of NE skills conclave for furtherance of investment in skill development in the region.
- (iv) An amount of Rs,.20.00 lakh sanctioned to NERAMAC for organising exhibition / fair to showcase the agricultural products of the region.
- (v) Financial assistance was granted to various governmental / non governmental / autonomous organisations to organise seminars, workshops, sports / cultural activities etc. to disseminate information / knowledge / potentials of North East among various target groups. The organisations include NE State Governments, ASSOCHAM, FICCI, ADDOI, Tangkhul Naga Society, Assam University, Silchar, etc.
- 6.7. An amount of Rs 6.30 cr has been utilised till 31.12.2011 out of the total allocation of Rs.7.00 cr. in 2011-12 under the scheme.



7. EXTERNALLY AIDED PROJECTS

7.1 ADB assisted North Eastern States Roads Investment Programme (NES-RIP):

The proposed North Eastern States Roads Investment Programme (NESRIP), a centrally sponsored scheme of the Ministry of Development of North Eastern Region is to be assisted by the Asian Development Bank (ADB). The total cost of the project in the first investment programme is US \$ 298.2 million. The ADB will contribute US \$ 200 million. The Government of India will contribute US \$ 83.30 million and the States' share is US \$ 14.9 million. The entire cost of the project including ADB's Loan Component of US\$ 200 million but excluding States' share will be released to the State Governments in the form of Grants-in-aid. A total length of 433.7 kilometers of roads and bridges covering six NE States, excluding Arunachal Pradesh and Nagaland is proposed to be taken up for construction / upgradation during Tranche I & II. Tranche I comprising the States of Assam, Meghalaya and Sikkim will cover a total road length of 202.3 kilometers and Tranche – II comprising Assam, Manipur, Mizoram and Tripura will cover the remaining road length of 231.4 kilometers.

7.2 Current Status:

- The Cabinet Committee on Economic Affairs (CCEA) in its meeting held on 19th May, 2011 has approved the project.
- Loan negotiations with ADB held on 16-17 June, 2011.
- The framework financing agreement has

- been signed between Government of India and ADB.
- The ADB Board of Directors has approved the Multi Tranche Financing Facility of US \$ 200 million for the Captioned Programme on 22nd July, 2011.
- The ADB management has approved Tranche-I loan of US \$ 74.8 million on 22nd August, 2011.
- Action for engagement of consultancy services (CSC & PMC) has been initiated both by the State Governments concerned and MDONER.
- Award of contracts for consultancy services is likely to be completed by March-April, 2012.
- Loan agreement (Tranche-I) is expected to be signed between Govt. of India and ADB after completion of award of contracts for consultancy services.
- Loan effectiveness will take place anytime within a period of 90 days after the signing of loan agreement and the construction/ civil works will start thereafter.

7.3 World Bank funded North East Rural Livelihood Project (NERLP):

M/o DONER proposes to implement the North East Rural Livelihood Project in eight selected districts of four States of Mizoram, Nagaland, Sikkim and Tripura

with soft loan assistance from the World Bank. The duration of the project is five years. The objective of the North East Rural Livelihood Project (NERLP) is "To improve rural livelihoods especially that of women, unemployed youth and the most disadvantaged, in four North Eastern States". The specific project objectives of NERLP are to:

a) Create sustainable community institutions around women Self-Help Groups (SHGs), youth groups of men and women (YG) and

- Community Development Groups (CDG).
- b) Build capacity of community institutions for self governance, bottom up planning, democratic functioning with transparency and accountability.
- c) Increase economic and livelihood opportunities.
- d) Develop partnership of community institutions for natural resource management, microfinance, market linkages, and sectoral economic services.

7.5 The total estimated cost of the project is Rs. 683.2 crores (\$ 144.4 million). The Bank will contribute Rs. 614.8 crores (\$ 130 million) (90%) as IDA soft loan and Ministry of DONER will contribute Rs. 68.4 crores (\$ 14.4 million) (10%) from its budget allocation. The proposed project has four major components viz. Social empowerment; Economic empowerment; Partnerships development & management and Project management.

7.6 Activities undertaken so far:

- I. In principle approval of the Planning Commission has been obtained vide Planning Commission's letter No. M-13048/36/2005-SP-DONER dated 01.09.2006.
- II. For effective implementation of the project, a North East Livelihood Promotion Society (NELPS) has been constituted and registered at Guwahati in May 2009. The Society has already started functioning from the month of December 2009, under the supervision of the Project Director.
- III. The Ex post facto approval for the creation of Autonomous Society (NELPS) and creation of temporary post at level of Joint Secretary to the Govt of India for the Project Director of NERLP was given by the Cabinet in its meeting dated 20th April, 2011.
- IV. For the year 2011-12, a provision of Rs.35 crore has been kept in the budget.
- V. A pre-appraisal mission was undertaken by World Bank from 18th 22nd April, 2011. As an outcome of it, the cost of project has gone up from US \$ 133.3 million to US \$ 144.4 million (Rs. 683.2 crores).
- VI. A meeting was chaired by Secretary DONER on 6th July, 2011 to deliberate on the issue of avoidance of duplication

- between NRLM of M/o RD and NERLP. The following conclusions were drawn:
- i) The NERLP is modeled on the IFAD funded North Eastern Regional Community Resource Management Project for Upland Areas (NERCORMP) which was implemented in two districts each in Meghalaya, Manipur and Assam. This model was successful in raising family incomes of the very poor in the project area. NERLP is modeled on NERCORMP and is being implemented in areas and states other than NERCORMP.
- ii) As the challenges of rural development and poverty alleviation in the North East are different from those of the rest of the country, it is decided to scale up the NERCORMP model. It is also expected that NRLM will borrow from the experiences of NERLP in the NE States.
- iii) The districts in which NERLP will be implemented in NER will not be covered by NRLM. Ministry of DONER has discussed with the Ministry of Rural Development and the States on this issue.

7.7 Present Status:

- i) The EFC, chaired by Secretary, Department of Expenditure in its meeting held on 29.07.2011 appraised the World Bank funded North East Rural Livelihood Project at a cost of Rs.683.2 crore (\$144.4 million) and recommended it for approval by the competent authority.
- ii) A copy of the Minutes of the EFC dated 29.08.2011 and a copy of the final EFC Memo was also forwarded to the Prime Minister's Office on 01.09.2011. As per the appraisal of the EFC, "Exit Strategy" of the Project and provision of CAG audit for project funds have been incorporated in the Project Implementation Plan document.

- iii) Technical discussion for implementation of NERLP was held between Govt. of India and World Bank on 30.09.2011.
- iv) Cabinet in its meeting dated 16.11.2011 has approved for implementation of World Bank funded NER Livelihood Project.
- v) World Bank Board has approved for implementation of NER Livelihood Project.

7.8 German Govt. funded Climate Change Adaptation Project in NER:

Climate change is emerging as the most serious threat to sustainable development, with adverse impacts expected on the food security, natural resources, environment, economic activities, human health and physical infrastructure. Climate change is an issue of great concern to the Indian government. The Govt. of India released a National Action Plan for Climate Change (NAPCC) in June 2008 outlining the national strategy to address the challenges posed by climate change. Keeping in view the concern of Govt. of India, M/o DoNER proposes to implement German Govt. funded 'Climate Change Adaptation Project' in the States of NER. There are two aspects of the CCA project i) Technical and ii) Financial. Technical part of CCA project is to be funded by GiZ (Govt. of Germany) while Financial part of the project is to be funded by a German Bank namely KfW.

7.9 GiZ funded CCA Project in NER:

The duration of the GiZ funded project is Three years. The total financial outlay is 7 Million Euro (approx Rs. 43 Crore). Out of which 5 Million Euro will be funded by giz as a grant while 2 Million Euro will be funded by State Govts. in the form of kind. The project is proposed to implemented in Sikkim, Meghalya and Nagaland. Other states in the region will benefit from the regional research, knowledge management and dissemination of project results. The overall goal of the project is that rural people in the NER can enhance their livelihood resilience and adaptive capacity to the impacts of climate variability and change. MEA, MHA, M/o Environment & Forests, DEA, D/o Expenditure and M/o Agriculture & Cooperation have given their NOC to the project but comments from Planning Commission is yet to be received. Implementation agreement has been signed between M/o DoNER (Govt. of India) and GiZ on 28.06.2011.

7.10 KFW funded CCA project in NER:

The total financial outlay of KfW funded CCA project is 97 Million Euro (approx Rs. 582 Crore). Out of which 76 Million Euro will be funded by KfW on loan basis and rest of the amount will be funded by GoI and State Govts. The duration is Seven years and will be implemented in the States of Assam, Meghalaya, Nagaland, Mizoram and Sikkim. The overall goal of the project is that "Rural people in the NER to enhance their livelihood resilience and adaptive capacity to the impacts of climate variability and change. regards obtaining NOC / Comments of the Ministries/Deptt./Organizations, M/o Environment & Forests being the technical Ministry has been requested for NOC. Reply from them is awaited. Once the NOC from MoEF is received, other concerned Ministries will also be requested for NOC.







8. STRENGTHENING & STREAMLINING SYSTEMS

- 8.1 One key issue in the development of the NE Region has been the systemic inadequacy in planning, implementation and monitoring. As a result, on the one hand there is a problem of proper allocation of resources and on the other hand project execution suffers from cost and time over-runs. The problem occurs even in the case of certain key infrastructure projects. As a result, the Ministry has been entrusted the task of monitoring many of the projects of other line Ministries. The Ministry has been trying to address the situation through regular consultations and appropriate mechanisms. Apart from regular coordination, the Ministry is closely monitoring the implementation of certain key infrastructure projects assigned by the Prime Minister. Improving and streamlining systems is a key component for proper planning and execution. The progress of the implementation of these projects by the line Ministries/Departments is updated and reports are sent to the PMO on monthly basis. The detailed information is hosted in the website of the Ministry (www.mdoner. gov.in).
- 8.2 The Ministry has framed new guidelines for NLCPR and has also set up a technical cell for quick review of the DPRs. Representatives from the States are called to make presentation and brief the NLCPR Committee on their projects. In addition, the Ministry is involving CPSUs to vet projects. It has taken the initiative to organize Development Seminars in the backward districts of the North-East Region. The Seminars are attended by officials of Central Ministries apart from senior officials of the State concerned and public representatives. The Development

- Seminars provide vital inputs from the grass-roots for planning and development by different agencies.
- 8.3 The Ministry has brought out the Human Development Report of North Eastern States. The report is an attempt to evaluate the performance of NE States on sectors having direct impact on human development such as health, education and basic civic amenities. The report will help the Central Ministries in better targeting of schemes and projects in these sectors in the region.
- 8.4 The Ministry has also taken up the issue of utilization and proper accounting of development funds with the NE States. The matter has been regularly raised by the Comptroller & Auditor General. In this regard, a number of meetings have been held with the representatives of the States and the problems have been identified. The States have been requested to streamline their procedures in consultation with the respective Accountant Generals. The Ministry is also supporting a training programme in financial management for the young civil servants of these States.
- 8.5 The Revitalization Committee of NEC recommended that for evaluation and monitoring activities of NEC schemes, Universities and Research Institutions of the region may be involved.
- 8.6 All projects of the Ministry are continuously monitored through periodical progress reports received from the State Governments, depicting both the financial and physical progress of the projects and also through review meetings and inspections

by officers of the Ministry. The procedure adopted for release of funds to the States for various projects stipulates conditions which ensure that the State Governments furnish Utilisation Certificates and other documents to the effect that the funds have been utilized for the purpose for which they were sanctioned.

- 8.7 The Planning and Development Department of each State, which is the nodal Department for NLCPR projects, has been entrusted with field inspections of the projects through senior officers of the State and submission of inspection notes. For each new project, the state/implementing agency is to identify a Nodal Officer, who is responsible for implementation of that project on schedule. Besides, the State Chief Secretary has been entrusted with the responsibility of quarterly review of each of the projects and to send the proceedings at the end of each quarter. In addition, the visits by the senior officers of the Ministry of DoNER is an effective tool for monitoring as well as identifying problem areas, verifying physical and financial progress for speedy implementation of NLCPR projects.
- 8.8 The North Eastern Region of India is known for its vast natural resources and is a cauldron of different people and cultures. Information about this Region, though available from various sources, is scattered. To mitigate this disadvantage, NEDFi is maintaining a web based portal called "NER Databank" with a view to provide information about North East India at a single source. Data on various sectors are being updated regularly. The details can

be browsed at http://db.nedfi.com/. The Corporation publishes "NEDFi Databank Quarterly Journal"- an economic journal on the North Eastern region on various sectors. NEDFi Databank Quarterly is an effort to attract investments and business to the region as well as be of use for research/study for students, policy makers and business persons.

- 8.9. Funding to PSUs under this Ministry and other agencies during 2011-2012: An amount of Rs. 2.00 crore has been sanctioned each to NERAMAC and NEHHDC as loan for meeting their working capital requirements during 2011-2012. An amount of Rs. 60.00 crore has been sanctioned to NEDFi as interest free loan recoverable in lump sum after 15 years from the date of sanction for Micro Finance Schemes during the year.
- 8.10 Details of allocation of funds and expenditure, scheme wise (plan / non-plan) during the year are at Annexure- III.
- 8.11 The Ministry has prepared Results Framework Document(RFD) and Citizen's Charter for 2011-12 providing objectives, success indicators, target values, standards for various services/tasks along with time frame for their undertaking by the Ministry. The details of the Strategic Plan and Citizen's Charter are available on the website of the Ministry (www.mdoner. gov.in). The Ministry has duly and timely completed all the mandatory requirements specified by the Performance Management Division of the Cabinet Secretariat as part of the Results Framework Document.
