Ministry of Development of North Eastern Region under its Central Sector Scheme "Capacity Building & Technical Assistance (CB&TA)" invites skill development proposals in the prescribed format, for North Eastern Region youths from Central and State Govt. organizations engaged in skill development programme.

- 2. Major conditions for the financial assistance are as under:
- (viii) Skill development programmes are intended for unemployed youth of North Eastern States to enable them to get gainful employment.
- (ix) Intending organisations should be capable of holding residential programmes preferably in North Eastern States otherwise at any other place in country convenient to NER youths.
- (x) The intending organization would have to give assurance of atleast 75% placement/employment after the programme.
- (xi) The area/sector of training is <u>Open</u> and may be according to the specialization of the intending organization. However, preference will be given to training programmes of following sectors/areas:-

- (xii) Duration of skill development programme will be short-term not exceeding 6 months and long term maximum one year
- (xiii) All expenses on skill development programme, as also boarding and lodging (for which intending organisation has to make arrangements) of the candidates would be borne by the Ministry.
- (xiv) Intending organisations will be responsible for selecting candidates with the help of State Govts. For this purpose reasonable expenses towards advertisement and or road shows will also be borne by this ministry.
- 3. Intending organisations must submit their proposals in the prescribed proforma available in the Ministry's web-site, addressed to undersigned not later than 31<sup>st</sup> July,2013. Organisations which have done the training programme earlier must furnish complete details of placement record with students' name, e-mail ID, mobile number, address and name of the employer with their name, e-mail ID, mobile number, address, land line number, salary / perks etc may be furnished and new ones must furnish their experience in this field and placement record as indicated above. Soft copy of the proposal has to be sent to the address mention below.
