**II. Functions**

The functions of the Samiti will be to render advice for the implementation of the policies laid down by Kendriya Hindi Samiti and Department of Official Language regarding the use of Hindi for official purpose in the Ministry of Development of North Eastern Region.

**III. Tenure**

The tenure of the Samiti will ordinarily be three years from the date of its constitution provided that:-

- (a) the Members of the Parliament who are the members of the Samiti shall cease to be the members of the Samiti as soon as they cease to be the Members of the Parliament;
- (b) ex-officio members of the Samiti shall continue to be the members of the Samiti as long as they hold the office by virtue of which they are the members of the Samiti; and
- (c) if any vacancy arises in the Samiti owing to the death of a member or owing to tendering of resignation by a member, the member so appointed against that vacancy shall hold office for the residual term of the Samiti.

**IV. Headquarter**

The Headquarters of the Samiti will be at New Delhi, but if considered necessary, it may hold its meetings at any other place also.

**V. Travelling and other allowances**

The Department of Official Language, Ministry of Home Affairs, Government of India, vide their Office Memorandum No. II/20034/04/2005-OL(Policy-2) dated 3rd February, 2006 has stated that as the 15 non-official members include 6 Members of Parliament nominated


in the Hindi Salahakar Samitis constituted by Central Ministries/Department, so the provision regarding traveling/daily allowance is made more elaborate in the following manner:-

- (a) The members of Parliament nominated in the Samiti will be paid traveling and daily allowance as per the provisions in the "Members of Parliament(Salary, Allowance and Pension)Act, 1954", amendments issued from time to time and rules made thereunder.
- (b) Travelling Allowance and Daily Allowance to other non-official Members of the Samiti will be paid as per the guidelines contained in the Department of Official Language OM. No. II/20034/04/86-OL(A-2) dated 22nd January 1987 and in accordance with the prescribed rates and rules as amended from time to time by the Government of India.

### ORDER

It is Ordered that a copy of this Resolution be communicated to all the members of the Hindi Salahakar Samiti of the Ministry of the Development of North Eastern Region, President's Secretariat, Prime-Minister's Office, Cabinet Secretariat, Ministry of Parliamentary Affairs, Lok Sabha Secretariat, Rajya Sabha Secretariat, Planning Commission, all Ministries/Departments of Government of India, all state governments and union territory administrations, Committee of Parliament on Official Language, Comptroller and Auditor General of India, Accountant General, Election Commission, Union Public Service Commission, Pay and Accounts Office, Ministry of DoNER and All Subordinate Offices/Autonomous bodies of the Ministry of DoNER.

It is also Ordered that this Resolution be published in the Gazette of India for general information.
