This is in reference to Cabinet Secretary's D.O. letter dated 11<sup>th</sup> May, 2011.

2. Secretary, DoNER chaired the First meeting of the Project Identification Committee (PIC) on 8<sup>th</sup> January, 2019 to discuss the projects/proposals under Hill Area Development Project (HADP).
3. An Inter-Ministerial Meeting on finalization of India's comments/inputs on draft Master Plan on BIMSTEC Transport Connectivity held in Ministry of External Affairs on 11<sup>th</sup> January, 2019 was attended by concerned officers from this Ministry.
4. MoDoNER keeps track of expenditure earmarked 10% expenditure in the North Eastern Region by non-exempted Ministries. As per PFMS data, the expenditure till 31<sup>st</sup> January, 2019 is Rs.23251.68 crore (consisting of release against Central Sector scheme and Centrally Sponsored Schemes) against the RE allocation of Rs.47087.95 crore for 2018-19.
5. In a meeting held on 21st January, 2019 under the Chair of Secretary, MDoNER it was decided to restructure the IT Team of MDoNER/NEC to meet their growing ICT needs such as MDoNER website, NLCPR Project, NESIDS Project Portal, MDoNER Data Portal, Track 10 Application, MyDoNER App.
6. The National Level level Steering Committee meeting for Science & Technology Intervention in NER (STINER) was held under the chair of Secretary, DoNER on 08.01.2019. It was agreed inter-alia that the NLSC would meet twice a year and the STINER implementing Committee (SIC) Chaired by Secretary NEC will meet quarterly.
7. A meeting was chaired by Secretary, DoNER on 09.01.2019 to discuss ways of enhancing awareness among people about various Government schemes/programs for successful implementation of Aspirational Districts Program/Extended Gram Swaraj Abhiyan in 14 Aspirational Districts of NER. It was decided that the strategy/initiative of this campaign - "Intensive Multi-Sectoral Strategic Communication development scheme" will be built around sports & games, songs & dance popular in local ethnic groups. Also, it was decided to establish a Community Radio at Chandel with the help of M/o I&B.


