Monthly summary of principal activities of and important decisions taken in the Ministry of Development of North Eastern Region during the month of July, 2019.

## 1.0 Principal activities and the important decisions:

- 1.1 Dr. Jitendra Singh, Hon'ble Minister of State (I/C), M/o DONER reviewed the status of implementation of various projects under MDoNER on 26.07.2019.
- 1.2 As a part of 100 Days Action Plan , the Ministry undertook 108 projects for Rs 1902.71 crore. These include 57 new projects sanctioned under North East Special Infrastructure Development Scheme (NESIDS) ,North East Road Sector Development Scheme (NERSDS), Natural Calamities-Flood Relief to North Eastern Region 2017 and Special Development Package for Karbi Anglong Autonomous Territorial Council (KAATC) for a total approved cost of Rs 1115.34 crore. Also a project for setting up of a Bamboo Industrial Park at Manderdisa in Dima Hasao District of Assam in an area of 75 hectares have been approved in principle for Rs 50 crore .
- 1.3 NEC under Agri & Allied Sector released a sum of Rs. 1794.64 Lakh for 4 ongoing projects, Rs. 41.09 Lakh was released for 1 ongoing project as last installment under IFC&WSM Sector and Rs. 1186.87 Lakh was released for 2 ongoing projects under HRD&E Sector.
- 1.4 Secretary DoNER along with Senior Officials of Ministry of DoNER visited Manipur from 16th to 18th July, 2019 and reviewed MDoNER and NEC Projects in a State level meeting. Field visits were also made to NLCPR, NEC and NERCORMP project sites of MDoNER/NEC and also to Sports University, Imphal and Integrated Check post at Moreh. He also reviewed the progress of various steps being taken by the district administration of Chandel Aspirational district.
- 1.5. Ministry was represented in the following significant meetings during the month of July 2019:
  - a. 9th meeting of the Empowered Committee (EC) on 'Trade Infrastructure for Export Scheme (TIES)' for Financial Year 2019-20 under the chairmanship of Commerce Secretary held on 15.07.2019 at 04.30 pm in Udyog bhawan, New Delhi.
  - b. Meeting held under the Co-chairmanship of Secretary (Defence Production) and Secretary (MoCA) to review the progress on the draft scheme for production of HAL's DO-228 aircraft for Regional Connectivity Scheme (RCS).
  - c. Inter-Ministerial meeting on Bangladesh-Bhutan-India-Nepal (BBIN) and Motor Vehicle Agreement (MVA) held on 23.07.2019 at South Block, New Delhi under the chairmanship of Shri Vikram Doraiswami, JS (BM & IP), MEA.
  - d. 9th Review Meeting of IMCCTS held on 23.07.2019 in Ministry of Tourism chaired by Secretary Tourism.
