**Monthly Summary of principal activities undertaken and important decisions taken during the month of June 2018.**

1. Ministry of DoNER keeps track of expenditure under earmarked 10% expenditure in the North Eastern Region by non-exempted Ministries. As per PFMS data, the expenditure in the first quarter of 2018-19 is Rs.7691.90 crore (consisting of releases against Central Sector Scheme, Centrally Sponsored Schemes and Other Grants/Loans/Transfers to NE States) against the earmarked allocation (BE) of Rs.47994.88 crore for the entire year. This data will help in recommending reallocation of likely surrender to those Ministries who have the absorptive capacity to implement additional approved schemes/ programs within the financial year.
2. The Hon'ble MoS (IC), DoNER reviewed the flood situation in Assam on 26<sup>th</sup> June 2018. During the review, he inter alia informed that financial assistance of Rs.200 crore has been approved by Ministry of DoNER, for reconstruction of totally damaged/washed away infrastructure due to floods in 2017 in the NE States.
3. Extended Gram Swaraj Abhiyan/Aspirational District (EGSA) Program:  
  
Secretary, DoNER held a review meeting of the EGSA with the senior officers of State Government of Assam at Guwahati on 26<sup>th</sup> June 2018. Ministry of MDoNER has been entrusted with the task of coordinating saturation of seven flagship programs in 14 Aspirational Districts of NE States under EGSA, including 7 in Assam. Earlier on 20<sup>th</sup> June 2018, a meeting was chaired by Secretary, DoNER on Aspirational Districts wherein nodal officers were assigned for each State. Secretary, North Eastern Council and his team of officers attended the meeting.
4. A meeting of Parliamentary Consultative Committee was chaired by the Hon'ble MoS, DoNER at Jammu on 14<sup>th</sup> June 2018.
5. During 25<sup>th</sup>-27<sup>th</sup> June 2018, Secretary, North Eastern Council along with NE State Representatives attended the Global Bamboo and Rattan Congress (BARC-2018) in Beijing, China.
6. Externally Aided Projects (EAP): A review of EAP proposals of NE States was held on 12.06.2018 under the Chairmanship of Secretary, DoNER to take stock of the EAP projects of NE States. Ministry of DoNER coordinates with MHA, MEA and NITI Aayog and gives its comments on EAP proposals from NE States.
