4. The Committee reiterated that the State Government while submitting the new project proposals under Special Development Package should provide the details regarding operationalization, maintenance and sustainability of the project along with all statutory clearances as per Annexure-A for Concept Notes and Annexure-B for DPRs, as per the guidelines for administration of Special Development Packages of BTC & KAATC issued vide No. NLCPR-12/6/2020-O/0 US(NLCPR) dated 03.10.2023.

5. It was mentioned that the SDP projects are taken on the basis of Memorandum of Settlement signed by the Govt. of India with the State Govt. and the respective territorial council/ ethnic group, and therefore, examination by Line Ministry/NITI Aayog should be expeditious.

6. The Chairman expressed his concern over low expenditure under SDPs, particularly Nil expenditures under BTC, for which he asked the concerned officers of Govt. of Assam to expedite the implementation of the ongoing projects and send the demand proposals to the Ministry as the current Financial year coming to end.

7. The meeting ended with a vote of thanks to the Chair.
