3. The Secretary, MDoNER requested all the three Territorial Councils of Assam viz. BTC, KAATC and DHATC to withdraw the balance amount from their respective CNA i.e. NEDFi as soon as possible so as to enable this Ministry to release additional funds against the ongoing projects wherever required.

4. The Chairman further reiterated to the State Government to submit pending Utilization Certificates and also to forward the demand proposals seeking funds against the ongoing projects to this Ministry along with all relevant documents for utilizing the budget allocated in BE 2025-26 and also to expedite the implementation of the projects.

5. The Committee expressed its concern for Nil Expenditures during April 2025 in respect of all three Councils and the concerned officers of Govt. of Assam were requested to expedite the implementation of ongoing projects.

6. The Committee further stressed that the State Govt. while submitting new project proposals under SDPs, should provide details as per Annexure-A for Concept Notes and Annexure-B for DPRs as per the Guidelines of SDPs of BTC & KAATC issued by this Ministry vide dated 03.10.2023.

7. The State Government of Assam was further requested to forward the DPRs of the Projects for which In-principle approval have been accorded by this Ministry.

8. The meeting ended with a vote of thanks to the Chair.
