Minutes of the 7th Empowered Inter-Ministerial Committee (EIMC) Meeting of PM-DevINE scheme held on 31.1.2024 at Vigyan Bhawan Annexe, New Delhi.

The seventh meeting of the Empowered Inter-Ministerial Committee (EIMC) for the PM-DevINE scheme was held on 31 January, 2024 at Vigyan Bhawan Annexe, New Delhi. The meeting was chaired by the Secretary, Ministry of Development of North Eastern Region (MDoNER) and aimed to deliberate on the project proposals submitted by the North Eastern states and other agencies for implementation. The meeting was attended by Chief Secretaries and senior officials from the North Eastern States, as well as Senior Officers from concerned Central Ministries and Departments. The list of participants is at **Annexure**.

- 2. At the outset, Chairperson and Secretary, MDoNER welcomed all officers present both physically and virtually and after introductory remark, he asked Sr. Economic Adviser, MDoNER to start presentation wherein the agenda of the meeting was discussed starting with ATR on the minutes of the last EIMC meeting held on 5.1.2024, followed by scrutiny of new candidate projects/ review of ongoing projects State-wise starting with Arunachal Pradesh. While supporting the proposal In-principle, NITI Aayog made certain observations that the State needs to mention the other source of funding for the Medical College and clarify the components supported under that scheme alongwith the items sought to be supported under the PM-DevINE scheme with timeline. NITI Aayog also requested for Non-Duplication and adheres to the latest NMC guideline construction operationalisation of the Medical College. These were shared with the State Govt. MoH&FW mentioned that they have already supported for upgradation of District Hospital to Medical College with the capacity of 50 seats in Gangtok at the same location, with a cost of Rs.250 cr. to be shared between Centre and the State in the ratio of 90:10, and the entire central share amount i.e. Rs.225 cr. had been released to the State Govt.

Chief Secretary, Sikkim mentioned that the instant proposal for gap funding of Rs.170 cr. is for the same medical college and they want to fully utilize the intake quota of the state by making the annual intake capacity of the college to 100 students.

The State Govt. was advised to recast the concept note giving full facts of the matter and addressing duly the observations of the NITI Aayog and M/o H&FW.

NITI Aayog was asked to provide its comments on the proposal at the earliest.	To be placed in the next EIMC meeting after obtaining the views of the NITI Aayog and D/o Telecom.



- 3. The competent authority has directed that comments of the line ministry and NITI Aayog may also be obtained after thorough examination of the DPR of the project in addition to thorough examination of DPR by the Technical Wing and IFD, MDoNER before issuing AFS.
- 4. The competent authority has also decided that the Govt. of Manipur may explore funding for Manipur International Convention Centre at Thengu Chingjin, Imphal East (Rs. 212 cr) under 10% GBS of the line ministry concerned or through NEIS. The State Govt. of Manipur may pose project(s), aligned with focus sector of PM-DevINE (Health, Education, Livelihoods), in place of Manipur International Convention Centre.
- 5. The Chairperson of the EIMC advised the State Governments to pose additional and **impactful** projects in line with the Scheme guidelines & within their balance share of indicated normative outlays under the scheme. The State Governments were also advised that new proposals should refrain from including non-admissible elements, as per the revised scheme guidelines.
- 6. States and other organizations/ agencies were requested to submit their proposals complete in all respects along with checklists, clearances, certificates etc., at the earliest so that those could be considered by the EIMC in its next meeting. The line ministries were also requested to expedite their comments on the project proposals as quickly as possible as this facilitates decision making by the EIMC.

The meeting ended with a vote of thanks to the Chair.
