A meeting of Empowered Inter-Ministerial Committee (EIMC) of 'Schemes of NEC' was held under the Chairmanship of Secretary, MDoNER on June 03, 2025 at 10:45 AM through VC in the Conference Hall, Jodhpur Officer's Hostel, New Delhi-110003. The list of participants is attached at Annexure-I.

2. Welcoming the participants, the presentation was made. The Agenda wise deliberations and decisions taken are as follows:

3. Agenda 1: Confirmation of minutes of previous EIMC meeting held on 21.03.2025.

5. Agenda 3: Proposal under 28% Central Agency Component which fall under the subject matter of EIMC: Detailed presentation was made by Invest India for the IPA proposal. After due discussions and deliberations, the committee made the following recommendations/observations:

Clarifications were given by Invest India to NITI Aayog's observations during the meeting. It was made clear that the Proposal is to strengthen the existing IPAs for each and every State, as a single IPA for the NER would not resolve issues specific to the State as the the investment ecosystem would vary from one State of NER to another significantly. Reference was made to the investment summits and roadshows organized by MDoNER in the past garnered around Rs 1.12 lakh crore intent of investment out of which only 5% only could be grounded due to various challenges including variation in land policies across states and due to lack of follow up by the States with the prospective investors. In the wake of the recent 'Rising North East' investment summit a total investment intent of Rs 4.3 lakh crore has been generated whose grounding would required substantial handholding.
