Monthly summary of principal activities of and important decisions taken in the Ministry of Development of North Eastern Region during the month of April, 2020.

# 1.1 Major activities/Key decisions pertaining to COVID-19

- i. Hon'ble Minister of State (I/C), MDoNER discussed measures being taken for the safety of people of North Eastern States in the wake of COVID-19 pandemic with the Senior officers of MDoNER, North Eastern Council (NEC) and North Eastern Development Finance Corporation Ltd. (NEDFi) through video conference on 3<sup>rd</sup> April, 2020.
- ii. On 15<sup>th</sup> April, 2020, Hon'ble Minister of State (I/C), MDoNER took a meeting with Senior Officers of MDoNER & Heads of Organisations under it (through video conference) and reviewed the activities of the Ministry and action being taken by it to mitigate the difficulties of people in North Eastern States in view of prevailing situation due to COVID-19.
- iii. On 27<sup>th</sup> April, 2020, Hon'ble Minister of State (I/C), MDoNER again reviewed covid-19 situation in NE States in a meeting with Senior Officers of MDoNER & Heads of Organisations under it (through video conference). He also discussed new health related proposals received from different NE States devoted to management of infections and Corona care, critical care and upgraded healthcare.
- iv. Chief Nodal Officers (CNO) and Nodal Officers (NO) for North Eastern States coordinated with North Eastern State Governments for regular monitoring of COVID-19 and helped them in resolving issues which required interventions by Central Ministries/Departments like issues relating to Department of Social Welfare's Pradhan Mantri Garib Kalyan Yojana Package and movement of required professionals and cargo by Ministry of Civil Aviation etc.
- v. Based on the inputs received from CNOs/NOs and the State Governments, a Daily report on the COVID19 situation is being posted in the Secretaries Group for information of Secretaries of the concerned Ministries/Departments.

- 1.2 21<sup>st</sup> meeting of Inter-Ministerial Committee (IMC)/NESIDS Committee was held on 23.04.2020 under the Chairmanship of Secretary, MDoNER, to discuss proposals received from the State Governments of Arunachal Pradesh, Manipur, Meghalaya and Mizoram for Strengthening Health Infrastructure for Fighting Corona Virus (COVID-19) for selection/sanction under North East Special Infrastructure Development Scheme (NESIDS). The meeting was cochaired by Chief Secretaries of all concerned States (through video conference).
- 1.3 Non lapsable Central Pool Resources (NLCPR) net accrual calculation for the year of 2018-19, was sent to Budget Division, Department of Economic Afairs, Ministry of Finance on 17.4.2020 for vetting and finalization.
- 1.4 NEC sanctioned an amount of Rs 25 crore to the eight NE States (Rs 5 Cr to Assam; Rs 3.25 Cr to Arunachal Pradesh; Rs 1.75 Cr to Sikkim; and Rs 3 Cr each to Manipur, Meghalaya, Mizoram, Nagaland and Tripura) as untied funds for various activities pertaining to COVID19.
- 1.5 Senior officers (SoM) meeting was held on 27th April, 2020 under the Chairmanship of Secretary, MDoNER with heads of all organizations and senior officers of the Ministry to review the progress of important matters of the Ministry
- 1.6 Expenditure of total Rs 54.26 Cr was incurred by MDoNER and NEC that includes funds released to NE States for the following projects implemented by MDoNER and NEC: Rs 4.19 Cr for 3 projects under Medical & Health Sector, and Rs 20 Cr for one project under Agri & Allied Sector by NEC; and Rs 60.58 Lakhs for one project to Mizoram under North Eastern States Roads Investment Programme (NESRIP) assisted by Asian Development Bank (ADB)
