
In partial modification of this Ministry's communication No. E and P-12/3/2022-O/o JD (FEA) dated 21.8.2023, the following amendments are hereby made in the guidelines for administration of the Prime Minister's Development Initiative for North-East Region (PM-DevINE) Scheme of the Ministry of Development of North Eastern Region (MDoNER):

(i)	<b>Para 7.1.5 Negative List</b>  (iv) Projects in sectors which are covered under any other scheme of MDoNER	Deleted.
(ii)	<b>Para 7.1.6 Minimum and Maximum Project Size:</b>  The minimum project size/cost will be Rs.20 crore while the maximum support per project will be capped at Rs.500 crore.	<b>Para 7.1.6 Minimum and Maximum Project Size:</b>  The minimum project size/cost will be above Rs.50 crore while the maximum support per project will be capped at Rs.500 crore.

2. The State Governments of North Eastern States/ Central Ministries/ Departments/ Other Agencies concerned will be at liberty to continue with the project proposals which have already been recommended by the Empowered Inter-Ministerial Committee (EIMC) for selection (in-principle approval) or sanction (DPR approval) under PM-DevINE Scheme, but the Administrative and Financial Sanction (AFS) has not been issued. These project proposals can still be considered for sanction or issuance of AFS (as the case may be) under PM-DevINE Scheme even though the size of these projects is less than Rs.50

crore. The projects, for which AFS has already been issued, shall not be affected.

3. This issues with the approval of the Competent Authority.


