**Monthly summary of principal activities of and important decisions taken in the Ministry of Development of North Eastern Region during the month of September, 2019.**

**1.0 Principal activities and the important decisions:**

1.1 Hon'ble MoS(IC), M/o DoNER took a review meeting on 27<sup>th</sup> September 2019 with officers of the Ministry, North Eastern Council and organizations under the administrative control of MDoNER.

1.2 A Meeting of Department Related Standing Committee(DrPSC) on Home Affairs was held on 30.09.2019 about functioning of MDoNER under the Chairmanship of the Committee Shri Anand Shama. Secretary MDoNER along with other officers of Ministry, NEC and Organisations of MDoNER attended the said meeting.

1.3 68<sup>th</sup> Plenary of North Eastern Council was held from 8<sup>th</sup> September to 9<sup>th</sup> September 2019 at Assam Administrative Staff College, Khanpara, Guwahati Hon'ble Home Minister and Chairman, NEC, Shri Amit Shah presided over the meeting.

1.4 NEC released funds for total 15 projects( 4 projects under Agri & Allied Sector ; 4 ongoing projects under IFC&WSM sector ; 5 projects as final installment and 3 ongoing projects under HRD&E sector) ; and also released fund to State of Meghalaya as financial support to the students of North Eastern Region for Higher Professional Courses(Rs.217.01 Lakh)

**1.5 Under 100 days Action Plan of MDoNER**

(i) Action plan of 205 projects costing Rs. 3247.33 crore has been implemented.(70 projects costing Rs 866.13 crore completed ; 110 projects costing Rs 1699.69 crore sanctioned ; 6 projects costing Rs. 39.95 crore operationalised ; and 19 projects costing Rs. 641.56 crore started.)

(ii) Completed a major project Construction of 66KV Transmission Line(charged at 33KV) from Ganeshnagar to Peren & construction of 5MVA, 33/11 KV S/S at Jalukie & Peren in Nagaland (Cost Rs. 21.78 crore)

(iii) Sanctioned a major project Construction-cum-double laning of the 64 k.m. of road from Diyungmukh to Umrongso via Panimur in Assam (Cost Rs.199.50 crore)

1.6 Ministry represented in the following significant meetings during the month of September 2019

(i) Meeting to discuss the status of linkage of Ministry's Portal with NGO Darpan portal of NITI Aayog & online processing of grants on 5th September, 2019.

(ii) Inter-Ministerial meeting on 12.09.2019 with M/o External Affairs on VVIP visit from Bangladesh to India in October, 2019. subsequently suggestions were provided towards enhancing trade in goods and services and investment between Bangladesh and North Eastern States for inclusion in joint statement of both the countries.

(iii) SFC meeting on Development of MSMEs (Entrepreneurship and Skill Development Programme) held on 25.09.2019 under the Chairmanship of Secretary, M/o MSME.

(iv) Meeting on 24.09.2019 with Vice-Chairman and CEO, NITI Aayog to review action taken on recommendations of the second meeting of the NITI Forum. The Ministries were requested to give their action plan and project fund requirements in a time bound manner for implementation of recommendations of the second meeting of the NITI Forum, pertaining to Bamboo, Tea, Tourism, Pisciculture and Dairy.

(v) Meeting held under the Chairmanship of Hon'ble Vice chairman, NITI Aayog on 24th September, 2019 to review the progress related to Subansiri Hydroelectric power Project on the border of Assam & Arunachal Pradesh.

1.7 Statistical Adviser of the Ministry, Chief Nodal Officer (CNO) of the Ministry for Udalguri Aspirational District and a Director, Nodal Officer of the Ministry for Baksa Aspirational District (both districts in BTC, Assam) visited the two districts from 25th to 28th September, 2019.
