OFFICE MEMORANDUM

Subject: Submission of Concept Notes/DPRs with the Gap Analysis on PM Gati Shakti Portal under the NESIDS (OTRI) Scheme.

The undersigned is directed to convey that the Ministry of DoNER had earlier issued the guidelines of the scheme of NESIDS (OTRI) vide MDoNER O.M. No. NESIDS/4/2020-US(NLCPR) dated 21.08.2023, which inter alia mandates, under point no. 4(k) of Annexure C, the submission of relevant document/analysis showing the alignment of the proposed project with the Gati Shakti Master Plan.

- 2. In this regard, it is stated that MDoNER has created its own instance of the Gati Shakti portal with the URL https://ne.pmgatishakti.gov.in/DoNER. This portal contains the geotagged details of all the ongoing and completed projects of MDoNER. It also contains the 1600 + layers pertaining to other Ministries of Govt. of India and State Governments.
- 3. The accounts of the planning departments of all the State Governments of NER have already been created on this portal. About 660 officials of 8 NER states were recently imparted training on the Gati shakti portal by the BISAG-N team and officials of MDoNER.
- 4. In view of the above, it has now been decided that it is mandatory for the State Government to select their projects, that are submitted for selection/sanction under the Schemes of MDoNER, based on the gap analysis done on the Gati Shakti Portal. The gap analysis must be incorporated in the Concept Notes/ DPRs before submission on the Poorvottar Vikas Setu portal.
- 5. Additionally, all the DPRs submitted to the Ministry for sanction must mandatorily contain the details regarding project completion timelines along with the PERT chart, provisions for operationalization of project, geo tagged photograph of the proposed project site and project implementation & monitoring structure at the level of state implementation agency.
